Eligibility	NTRP ratings will be used, and you must turn 19 years of age in 2009 to play. Players may play in only one division. The Tournament Committee reserves the right to reclassify or reject any entrant.
Rules of Play	All tournament procedures will be governed by USTA rules. The best 2 out of 3 sets with a ten point tiebreaker in lieu of the 3rd set, until semifinals, which will be best 2 out of 3 sets. Inclement weather may result in the use of no-ad scoring, pro-sets, or cancellations. Events with less than four (4) entrants may be combined or cancelled. If entire event is cancelled due to weather, all proceeds will be donated to LPCF.
Dress Code	At CCLA, all players must conform to its 80% white dress rule on <b>all</b> apparel, except warm-ups. Shoes must conform to clay court usage. <b>NO RUNNING OR CROSS-TRAINER SHOES ALLOWED!</b>
Tournament Director	Donni Leaycraft will be the tournament directory, and Randy Dornier will referee, if necessary.
Awards	Champion, Finalist, and Consolation Draw awards will be given at each level.
